FEEDING DIRECTIONS

*This feed is designed as a grower-developer creep feed for show cattle up to 900 lbs, but may be fed to cattle of any age or weight with proper management. Feed complete ration to show cattle at a rate of 4 - 22 lbs per head per day to cattle weighing 150 - 900 lb. to provide 79.0 - 434.5 milligrams of *Monensin* per head per day. It is important to provide available forage as an addition to their daily intake. Provide cattle continuous access to clean, cool water. Store feed in a cool, dry location free of insects, rodents, and other pests. **Do not feed if mold or infestation occurs.***

CAUTION FOR ALL PRODUCTS CONTAINING MONENSIN: DO NOT allow horses or other equines access to feeds containing *Monensin*. Ingestion of *Monensin* by horses has been fatal. *Monensin* medicated cattle and goat feeds are safe for use in cattle and goats only. Consumption by unapproved species may result in toxic reactions. Feeding or mixing errors resulting in high concentrations of *Monensin* could be fatal to cattle and goats. **DO NOT** exceed the levels of *Monensin* recommended in the feeding directions as reduced average gains may result. If feed refusals containing *Monensin* are fed to other groups of cattle, the concentration of *Monensin* in the refusals and the amount of the refusals fed should be taken into consideration to prevent *Monensin* overdosing. A withdrawal time has not been established for pre-ruminating calves. **DO NOT** use in calves to be processed for veal.

CAUTION: Contains copper **DO NOT** feed to sheep!
